BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

SECTION 1. That Section 175-31m Schedule XX, (175-95) of Ordinance No. 1960 be and the same is hereby amended and supplemented so as to establish "SPECIAL PURPOSE PARKING ZONES, HANDICAPPED PARKING ONLY" restriction on the following roadway:

a) At 853 Penn Street, one space in front of residential dwelling.

SECTION 2. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the designated section or zones giving notice of this regulation aforesaid.

SECTION 3. Any ordinance or part of an ordinance to the extent that it is inconsistent herewith is hereby repealed.

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, FURTHER AMENDING AND SUPPLEMENTING ORDINANCE NO. 1960, ADOPTED JUNE 30, 1986, AND KNOWN AS THE "GENERAL LAWS OF THE TOWNSHIP OF HAVERFORD" CHAPTER 30, ARTICLE III, POLICE PENSION PLAN.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

SECTION 1. That Chapter 30, Article III, Police Pension Plan shall be amended and supplemented as follows:

A. Paragraph 30-12 Retirement; honorable discharge; police reserves. (B) shall be replaced in its entirety by the following:

Early Retirement.

- a) Eligibility Requirements. A member will be eligible for early retirement benefits provided he retires from the Township Police Department and has completed at least 20 years of service with the department except that such service requirement shall be reduced to 15 years if the member was hired on or before January 1, 2000 and is at least age 50 at retirement.
- b) Benefit Commencement Date: Monthly benefits as described in (c) shall commence on the first day of the month coincident with or next following the member's date of retirement.
- c) Amount of Benefits: The amount of monthly benefit payable to the member shall be equal to the actuarial equivalent of a partial normal retirement benefit and shall be calculated as  $(i) \times (ii) \times (iv) + (iii) \times (iv)$ , where (i) (ii), (iii) and (iv) are as follows:
  - (i) 50% of the member's final 36 month average salary at retirement.
  - (ii) A fraction, the numerator of which is the member's years of service at early retirement and the denominator of which is the projected years of service the member would have based on continued service to his normal retirement date (i.e. the date on which he would have attained age 50 and completed 25 years of service).

- (iii) An additional benefit of \$20 per month for each full year of service over 25 years, to a maximum additional benefit of \$100 per month.
- (iv) An early retirement actuarial equivalent factor where such factor shall reflect the fact that the partial normal retirement benefit (determined as (i) x (ii) + (iii) above) is to commence immediately rather than on the member's projected normal retirement date and shall be calculated using the interest and life expectancy assumptions reported in the last actuarial valuation report filed by the Township with the Public Employee Retirement Commission, pursuant to Act 205 of 1984 (as amended) of the Commonwealth of Pennsylvania.

B. Paragraph 30-12 Retirement; honorable discharge; police reserves.(G) shall be added as follows:

**Cost-of-Living Adjustments**

On each January 1 following his date of retirement, a member who retired after January 1, 2000, shall have his pension increased by 100% of percentage increase in the Consumer Price Index as published by the U.S. Department of Labor for the Philadelphia Wilmington, Atlantic City region (or its successor region) for the 12 month period ending with August of the preceding year, subject to the following qualifications:

- a) The increase due the first January 1 following the member's retirement shall be equal to 100% of percentage increase in the Consumer Price Index, determined as described above, multiplied by that fraction of the preceding year during which the member was retired.
- b) A member's total pension after successive annual applications of this cost-of-living provision, as described through (a), shall not exceed the lesser of (i) 115% of his initial pension and (ii) 75% of the salary upon which the member's initial pension was based.

SECTION 2. Any ordinance or part of an ordinance to the extent that it is inconsistent herewith is hereby repealed.

SECTION 2. That Section 4-608 (B) shall be amended to provide the Board shall immediately appoint two additional members whose terms shall respectively expire in December, 2003 and December, 2004 and that at the end of the expiration of the terms of the current members, their succeeding appointees shall be appointed for a term of five years provided that it is so fixed that the term of office of one member shall expire each year.

(B) MEMBERSHIP OF THE BOARD. The membership of the Zoning Hearing Board shall be appointed by the Board of Commissioners consistent with the provisions of Section 4-607 et seq. of the Township Administrative Code.

- b) Section 30-33 shall be changed to add this paragraph: an employee has the option of normal retirement at age 60 with twenty-five (25) years of service.
- c) Section 30-33, Paragraph C, shall be changed to clarify that normal pension benefits shall be computed based upon total compensation received during the highest thirty-six (36) months of employment prior to the retirement date.
- d) Section 30-34 shall be replaced in its entirety with the following:  
"Any member employed by the Township for at least six (6) months and who thereafter enters into the military service of the United States shall have credited to his or her employment record, for pension calculation purposes, all of the time spent by the member in such military service provided that such member returns to the Township's employ within six (6) months after separation from such military service." An actuary study shall be made to determine costs to be paid.
- e) Section 30-36 shall be changed to provide a non-service connected disability benefit of 30% of salary regardless of years of service or, if greater, the employee's accrued benefit reduced by 5% for each year that commencement precedes age 60. The amount of service connected disability payments under the Pension Plan will be reduced by any benefits to which you may become entitled under the Pennsylvania Workman's Compensation Laws or any Acts of the Pennsylvania Legislature. However, in no event will a combination of monies received from service-connected disability pension and worker's compensation exceed seventy (70%) of total compensation paid to the employee over the twelve (12) months preceding the disability retirement.

SECTION 1. The total amount of the annual sewer rental or charge for the year 2001 to be required is hereby determined to be \$3,344,980 pursuant to and as part of the Budget Adoption procedures of the Home Rule Charter.

SECTION 2. The Board of Commissioners does hereby determine Two Dollars and forty cents (\$2.40) per one thousand (1000) gallons of water used by properties connected with the sewage of the Township as the amount of money to be charged to each property connected to the Township Sewer System for the sewer rental or charge for the year 2001.

SECTION 3. The sewer rent or charge for the year 2001 for each property within the Township of Haverford using the sewer system and facilities of the Township shall be charged at the rate of \$0.00240 per gallon for water consumed or used by said property.

SECTION 4. A two percent (2%) discount shall be allowed if the bill is paid on or before sixty (60) days from the date of the bills. The face amount of all final bills shall be payable on or before one hundred and twenty (120) days from the date of the bills if discount period is disregarded. All sewer rental charges shall be a lien against the property serviced by the sewer facilities of the Township until said sewer rental charges are paid. Failure on the part of the Township to remit a bill due to administrative error or federal postal delivery problems does not exonerate the property owner from paying the sewer rental fee and penalties imposed. It shall be the duty of the Director of Finance to certify to the Township Manager/Secretary the date that all bills are mailed. If said bills are not paid on or before one hundred and twenty (120) days from the date of the bill, a penalty of ten percent (10%) shall be added. It shall be the duty of the Director of Finance during or after the twelfth month following the month in which bills were mailed to certify the unpaid bills to the Township Solicitor, who shall proceed to collect such delinquent sewer rental together with penalties and costs accrued thereon in addition to attorneys' fees pursuant to Act 1, Commonwealth of Pennsylvania, February 2, 1996 either by action at laws, or by filing a lien or liens for the same in the office of Judicial Support of the Court of Common Pleas of Delaware County, Pennsylvania and such liens, together with penalty and costs accrued thereon in addition to attorneys' fee shall be filed and collected in accordance with law. All sewer rentals not paid prior to the date on which penalty shall be added as herein provided shall be deemed to be delinquent.

Pursuant to Section 707, paragraph A of the Home Rule Charter, the Board of Commissioners hereby authorizes the Township Manager to enter into an Amended Lease Agreement with Unisite, Inc., d/b/a American Tower Corporation to expand the lease of property to American Tower Corporation to include approximately 825 square feet of a portion of the Municipal Lands located at 2325 Darby Road as shall be more fully described in the Amended Lease Agreement.

SECTION 2. American Tower Corporation agrees to pay to the Township of Haverford such sums in the amounts and as are set forth in the Amended Lease Agreement as aforesaid.

SECTION 3. The terms and conditions of the Amended Lease Agreement shall be to the satisfaction of the Township Manager and in accordance with the recommendations of the Township Solicitor.

SECTION 4. Any Ordinance or any part of an Ordinance, to the extent that it is inconsistent herewith, is hereby repealed.
